Year 10 Work Experience: Monday 4 July 2022 - Friday 8 July 2022

We are organising a Work Experience Week for Year 10 students during the above week. This will involve students spending the week in a local company or organisation in conditions and on tasks as close as possible to those of regular employees, with the exception that the work is unpaid. We understand that since Covid some workplaces are still working remotely and as such, some placements may need to be online and involve working from home.

The aim of the placement is to provide an opportunity for young people to gain a first-hand insight into the world of work. The experience provides a valuable opportunity to assess and develop their employability and social skills in a new and adult environment. It is in this area that we have found in previous years that students have gained the most.

We strongly encourage parents to be involved in the process of finding work experience and to support students to find their own placement as we believe this to be an important part of the overall experience. Support will be given to students looking to secure their own placements with C.V.'s, phone calls etc. Where it is not possible for students to arrange their own placement they can apply for a school arranged placement.

All work experience placements will be health and safety checked by Safety Measures, the school's Health and Safety Provider. Further information about this can be found on their website: www.safetymeasures.work-experience.co.uk



1. Students applying for their own work experience placement

After choosing this option and returning the slip below, students will be given an "Employer Offer of Placement" form. This should be sent to the employer and returned to me by yourselves or by the employer directly.

(Please note the deadline for returning Employer forms is **not** Thursday 4 November 2021 – that is the deadline to let me know whether you will be organising your own placement or would like school to do so. Employer forms will need to be returned by Monday 21 February 2022)



















2. Students applying for a school arranged placement

Students will be given a list of possible work experience placements to choose from. The student will then be allocated a placement but it must be noted that in some instances it is not always possible for them to receive their first choice of placement. Please also be aware that if there are insufficient placements some students may need to remain in school and take part in organised activities around work experience.
